Glucose oxidase from Aspergillus niger is a dimer that consists of 2 equal subunits with a molecular weight of 80 kDa each. Each subunit contains one mole of flavin adenine dinucleotide and one mole of iron. The enzyme is a glycoprotein with ~16% neutral sugars and 2% amino sugars. The enzyme also contains 3 cysteine residues and 8 potential sites for N-linked glycosylation.4

Glucose oxidase oxidizes D-aldohexoses, monodeoxy-D-glucoses, and methyl-D-glucoses at varying rates, in the following qualitative, decreasing order:

D-glucose > 2-deoxy-D-glucose > 4-O-methyl-D-glucose > 6-deoxy-D-glucose > 4-deoxy-D-glucose > 3-deoxy-D-glucose >

3-O-methyl-D-glucose

Glucose oxidase has a pH optimun of 5.5, and generally has a broad activity range of pH 4-7.2 Glucose oxidase is specific for β-D-glucose with a K_m of 33-110 mM.5,6

Glucose oxidase does not require any activators. Inhibitors of glucose oxidase include Ag⁺, Hg⁺², Cu⁺², phenylmercuric acetate, and p-chloromercuribenzoate. Nonmetallic SH-alkylating reagents such as N-ethylmaleimide, iodoacetate, and iodoacetamide do not inhibit the enzyme.7

Glucose oxidase can be utilized in the enzymatic determination of D-glucose in solution. As glucose oxidase oxidizes β-D-glucose to D-gluconolactone and hydrogen peroxide, horseradish peroxidase is often used as the coupling enzyme in glucose determinations. Although glucose oxidase is specific for β-D-glucose, solutions of D-glucose can be quantified, as a-D-glucose will mutorotate to β-D-glucose as the enzymatic reaction consumes β-D-glucose.8

Preparation Instructions

This enzyme is soluble (1.0 mg/mL) in 50 mM sodium acetate buffer, pH 5.1, yielding a clear solution.
