



## RABBIT ANTI-HUMAN INSULIN REGULATABLE GLUCOSE TRANSPORTER 1 (GLUT-1) POLYCLONAL ANTISERA

**EPITOPE:** C-terminus

SPECIFICITY: The affinity purified antisera is specific for human glucose transporter 1 from muscle and

adipose tissue. Does not cross-react with GLUT-4. The molecular weight of the glucose transporter precipitated by the serum is approximately 46 kDa. KNOWN SPECIES CROSS REACTIVITY: The antisera is known to crossreact with rat and

mouse GLUT-1

APPLICATIONS: Western blot analysis of GLUT-1 activity in adipose and muscle tissue (5µg/ml)

Immunoprecipitation of GLUT-1 (5µg/ml)

Optimal working dilutions must be determined by the end user.

**SPECIES REACTIVITY:** Reacts with Human, Mouse and Rat. Reactivity with other species has not been determined.

**IMMUNOGEN:** 12 amino acid peptide of the C-terminus of hGLUT-1 {LFHPLGADSQV} conjugated to KLH

**FORMAT:** Affinity purified on a Sepharose-4B CNBr linked peptide column

**PRESENTATION:** The polyclonal is presented in phosphate buffered saline containing 10mM sodium azide. We

recommend that each laboratory determine an optimum working titre for use in its particular

application.

STORAGE/HANDLING: For use within 1 month of purchase store at +4°C, for long term storage aliquot antibody into

small volumes and store at -20°C for up to one year.
